I understand that all bills will be due upon receipt, and that any bill not paid by the due date, will be charged a penalty fee of 10% of the current bill. I understand that if I do not pay the bill in full within 48 hours, I will have to pay the bill in full, plus an administrative fee of \$50.00 per service in order to be re-connected. I further authorize the Town to enter the premises for the purpose of activating or de-activating services. I also understand that I will be charged a minimum charge from the day services are connected until the regular reading date, even if it is less than one month. I have been informed that if there have never been services at this address before, it will take a minimum of fourteen (14) working days AFTER payment has been received in this office to have services ready for me. I agree that if the Town renders the service herein requested that this request shall become a contract between me and the Town I understand that this contract is not transferable or assignable.
