## ORDINANCE NO. 2023 - 10

**AN ORDINANCE OF THE TOWN OF LAMONT, OKLAHOMA AMENDING THE LAMONT CODE OF ORDINANCES CHAPTER 8 HEALTH AND SANITATION; ADDING SECTION 8-604, PENALTY CLAUSE; PRESCRIBING AN EFFECTIVE DATE; AND DECLARING AN EMERGENCY.**

**BE IT ORDAINED BY THE MAYOR AND THE TOWN BOARD OF LAMONT, OKLAHOMA AS FOLLOWS:**

That the Lamont Code of Ordinances, 2014 Chapter Eight, Health and Safety, is hereby amended by adding Section 8-604, Penalty to Article 6, Enforcement. To wit:

### **Section 8-604 Penalty**

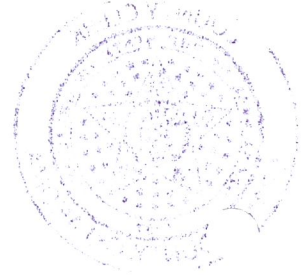
Any person, firm or corporation who violates any provision of this Chapter, or any ordinance, code or standard adopted by reference by this Chapter, or maintains or permits to continue any public nuisance as defined by this Chapter, or who violates or neglects to carry out any reasonable order, pursuant to this Chapter, made by the police or any authorized employee, agent or officer of the Town, shall be guilty of an offense and, upon conviction thereof, be fined in a sum not to exceed \$249.00 and shall be subject to revocations of any license(es) or permit(s) which may have been issued pursuant to the provisions of this Chapter. In addition, thereto, such person may be enjoined from continuing such violations. Every day's violation of any provision of this Chapter, or of such order of the police or any authorized employee, agent or officer of the City, shall constitute a separate offense.

**CODIFICATION.** The Town Clerk is hereby directed to enter the amended sections into the appropriate place in the Town of Lamont Code of Ordinances, as authorized and approved by this Ordinance.

**SEVERABILITY.** If any provision, paragraph, word, section or article of this Ordinance is invalidated by any court of competent jurisdiction, the remaining provisions, paragraphs, words, sections and chapters shall not be affected and shall continue in full force and effect.

**REPEALER.** All other Ordinances and parts of other Ordinances inconsistent or conflicting with any part of this Ordinance are hereby repealed to the extent of such inconsistency or conflict.

**EMERGENCY CLAUSE.** An immediate necessity existing for the preservation of the public peace, health and safety, an emergency is hereby declared to exist by reason of which this ordinance shall be in full force and effect from and after its passage, approval and publication or posting.
